**PUBLIC HEARING TO BE HELD JUNE ON PLANNED CHEMOURS ROSS HOLLOW LANDFILL EXPANSION**

The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has tentatively decided to issue a new solid waste disposal facility permit major modification to the Chemours Company FC, LLC (Chemours) for their Class II landfill. This permit will result in 12.46 acres to be used for disposal over mostly previous landfill areas. The facility, identified as Ross Hollow Class II Landfill (IDL 430000218), will be located in Humphreys County at 1950 DuPont Road, New Johnsonville, Tennessee (latitude 36.041161 N /longitude 87.966470 W). This permit would allow construction, operation, closure, and post-closure care of the Class II disposal facility for the disposal of iron-rich coproduct waste, wastewater treatment ponds' dewatered solids, and other process wastes listed in their permit, generated at the Chemours Johnsonville Plant and/or certain wastes having similar characteristics and approved in writing by TDEC. No hazardous wastes, as regulated by the Tennessee Hazardous Waste Management Act (Tennessee Code Annotated, Section 68-212-101, et. seq.) and the Rules adopted pursuant to the Act, shall be accepted for disposal at this facility. The official responsible for operation of the facility is Mr. Robert Vargas, EHS Consultant, The Chemours Company FC, LLC, 1950 DuPont Road, P.O. Box 219, New Johnsonville, TN 37134 (931-535-7240). DSWM has made a preliminary determination that the Chemours landfill application meets the applicable requirements of Tennessee Rule Chapter 0400-11-01, Solid Waste Processing and Disposal. Pending consideration of any comments received during the 45-day comment period ending on June 22, 2020, DSWM intends to issue this permit. In accordance with current State of Emergency and State and Federal directives to avoid public gatherings, DSWM will hold the public hearing described herein, via video-conference. Information on how to join the online public hearing is provided below. Those without internet access may join by phone or may provide written comments. The hearing, which is being scheduled at the request of the applicant, Mr. Robert Vargas, EHS Consultant, will be held on Thursday, June 4, 2020. Those with internet access may join the online public hearing using the following link <https://tngov.webex.com/tngov/j.php?MTID=mf9b04e575e2263f3b00d8d0ad5f1d4fc>. To log in, please use the meeting number (access code): 612 680 029. Alternatively, interested parties can call in to the meeting at 415-655-0003 using the access code 612 680 029. Participants are highly encouraged to join online or with the WebEx app in order to view maps, pictures, and other content which will be shared. Information regarding how to join by computer will be posted to the following website at least 3 days prior to the public hearing: <https://www.tn.gov/environment/ppo-public-participation/ppo-public-participation/ppo-waste.html>. The videoconference will open to participants at 5:15 p.m. From 5:30 p.m. to 6:00 p.m. CST, an informational session will be held in which DSWM and representatives of the applicant will be available for discussion and review of the permit application, draft permit, fact sheet, plans, and other materials provided. There will also be an opportunity for comments to be recorded or written and submitted during this time. The formal hearing will begin at 6:00 p.m. First DSWM will explain its tentative decision to issue the permit. The applicant's representative will describe the proposed facility action/expansion. DSWM will then receive oral comments on the draft permit from the public. DSWM invites the public to review and submit comments on this proposal at the hearing or anytime during the 45-day comment period ending on Monday, June 22, 2020.
